### **RESIDENTIAL UNIT RENTAL PACKAGE**

Old School Commons Unit Owners are to follow the below terms for renting out their residential units at Old School Commons Condominiums:

- 1. <u>Unit Owner must notify the Association's managing agent</u> (Kendrick Property Management) **prior to advertising**, <u>listing</u>, or executing a rental and upon the termination of any lease.
- 2. No subletting is allowed. This must be stated in any rental agreement signed with residential tenants.
- 3. No owner may rent out a unit unless all Unit Owner accounts are paid in full.
- 4. All tenants must acknowledge receipt of a copy of the Rules and Regulations (see attached form).
- 5. Failure of any tenant or owner to follow the Rules and Regulations may result in fines against the Unit Owner.
- 6. TENANTS ARE NOT ALLOWED TO HAVE PETS.
- 7. A fine of ONE THOUSAND DOLLARS (\$1,000) will be imposed against any Unit Owner who fails to secure advance permission for a rental (see attached).
- 8. Additional fines may be imposed by the Trustees per Trust Section 5.29, for \$100 per day after the notice to an owner in violation of the condominium rules is provided. This is in addition to the \$1000 fine.
