In 2019, the Trustees approved a consistent 4% to keep up with inflation and maintain funds to the Reserve. For 2021, the possibility of not raising the fee due to the economic impact of the

pandemic was discussed. Trustees voted to continue with the 4% annual increase as had been put in place in 2019.
